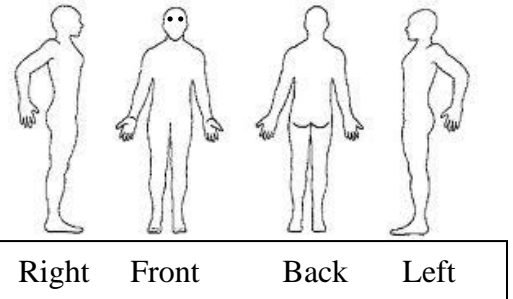

- 2) **Informed Consent:** Chiropractors do not diagnose diseases. Our job is to find areas of nerve interference and to remove it. We suggest that you visit your medical doctor in order to care for any health concerns other than Nerve Impingement. We also want you to realize there are risk factors involved in any form of health care. Surgery may have death risk factors of anywhere from 1/1,000 to 1 in 100. Medication may cause serious reactions in 1/100,000 to 1 in a thousand cases. Proper chiropractic adjustments almost never result in serious reactions: less than 1 in a million, but may include sprain, cerebrovascular accident or disc damage.
